It Might Have Been the Time...



IT is hard to say just when Alcoholics Anonymous began. It may have been at the time a friend came to see my husband, Bill. Or it may have been at the moment of Bill's spiritual experience. Most AAs feel it is the time six months later when he met Dr. Bob in Akron and, together, they started to help other alcoholics who wanted to be rid of their addiction.

But for me it was the day I first saw the released expression on my husband's face. We had been married 17 years, and were compatible and companionable. Our interests were similar and we both deeply desired and strove for the other's welfare. The only, but considerable block to our happiness was Bill's uncontrolled drinking. In the early years he said that he could stop when he wanted and I thought I'd soon be able to make life so complete for him that he would wish to guit drinking entirely. Much later when he really did want to stop, he was absolutely unable to do so, and we both then became terribly confused and frustrated. Oddly enough he had been in other matters a person of strong will power, but his will seemed to melt away where alcohol was concerned. In his remorse and disappointment he was an Akron surgeon soon to become coa tragic and heart breaking figure. I too felt founder of Alcoholics Anonymous. Bob too myself a failure, for despite every endeavor, I had not been able to help him in time, nor could I aid him in the least in his final struggle for freedom.

TODAY I can talk and write about these intimate details of our life together. While Bill was drinking, I dared not even speak to my family about it and tried to hide the fact of his alcoholism in every Bill was actually a very sick man, that awful feeling of disgrace has left me. I have also learned how much help the telling of such experiences can be to those who are going through similar ones. After fifteen years in AA the old trying times are so far away and foreign to Bill's and my present way of life that it seems like the experience of someone else.

AFTER Bill left the hospital for the last time, he began to think of the thousands of alcoholics who wanted to be rid of their

malady. If they could be made to feel desperate enough, they might have a releasing experience just like his. He would hold before them the medical verdict that alcoholism was hopeless. So tirelessly, day and night, we worked. Our home was filled with alcoholics in various stages of sobriety. As many as five of them lived with us at one time. But none of them stayed sober for long. Then started a long process of trial and error, certain ideas were retained, but many discarded.

It was in June 1935 that Bill went to Akron, Ohio on a business trip. The venture failed. He finally contacted Dr. Bob, wanted above all to stop drinking. He and his wife, Anne, had done everything they could.

SOMETHING passed between these two men. There was real mutuality this time. By example they showed how it worked. Thus AA spread like a chain letter.

Bill had learned a great deal. At first way possible. Now that I have learned that he had tried to put every alcoholic he met in the way of a spiritual experience just like his own. As AA grew, he realized that what had come to him in a few dramatic minutes usually dawns on others in months or years. Sometimes the alcoholic himself does not even realize his own development, though his words and actions soon speak for him, for he is doing now what, of himself, he was unable to do before. He is staying sober and helping other people as never before. He is gaining a serenity, a joy in living.

WATCHING Bill and the other men at the meetings, I noticed many of them had begun to grow by leaps and bounds. This made me look at myself. I had been given a sound religious upbringing and felt I had done for Bill all a good wife could do, although this was strangely mixed with a sense of failure. At first it never occurred to me that I too needed spiritual development. I did not realize that by living such an abnormal life, I might have become twisted, losing a sense of true values. After awhile I saw that unless I jumped on the bandwagon too, I would be left way behind. The AA Program I found could be most helpful to the non-alcoholic as well, a fact thousands of alcoholics' relatives and friends now apply to their own lives.

Those Clinton Street days are full of memories. Some of them are humorous, some tragic. But most of them bring back

a warm glow of hope and courage, of friendship and rebirth. For the fellowship in AA is unique. Ties are made overnight that it would take years to develop elsewhere. No one needs a false front. All barriers are down. Some who have felt outcasts all their lives, now know they really belong. From feeling as if they were dragging anchor through life, they suddenly sail free before the wind. For now they can be of tremendous and peculiar use to others having a dire need like their own.

GOD SPEAKS THROUGH HIS KIDS

In a relationship based upon the Traditions there is no such thing as individual authority. All decisions are arrived at by a majority agreement, reached after all elements of the problem or situation have been considered and a Higher Power has been contacted for guidance in the making of the decisions (an informed group conscience). Unfortunately, however, many times our relationships are unhealthy due to the dominance of one person or the other. The uninformed often times feels he/she has the ability to "know best" for its individual participants and tries to impose this attitude of "playing God" in the relationship.

All my life I feared authority. I had a very strange idea about it. I didn't like anybody else's authority. I only liked my own authority. Maybe it is not so strange if you're a sick alcoholic like me. But I certainly did not have any respectful attitude

for authority.

My first successful experience in not being fearful of authority was in A.A.. I did not fear my sponsor but relied on him. I saw my sponsor as the expression of a loving God. My second experience in not being fearful was when I started listening to the group conscience. The more I followed what I heard in A.A. through the group conscience, the better my life became. Gradually I have extended this trust me to come to believe. in the group in A.A. to that of the world. Tradition 2 encourages me to listen in order to have good relationships with you and to trust you as part of the group conscience. God may, just may, be speaking through you.

Life forces me to become an elder statesman or a bleeding deacon. The group conscience will correct me if I am out of line and I have a choice to complain like a bleeding deacon or lead by humble

example like an elder statesman. THANK GOD A.A. is SELF-CLEANING (with God's help of course).


Step-Tradition Parallel: Each tradition answers the question raised by the parallel step. The second step raises the question of how I can come to believe and what is sanity. I came to believe by trusting the group conscience in A.A., and then I began to trust God and eventually the world. The experience of trusting A.A. to keep me sober is the experience that gave me confidence in God and in you. This is how the second tradition helped

As it states at the top of this page, the 12 Traditions were created to help each A.A. group maintain unity and relate better to the world about us. With that in mind, they have been widely used in helping us learn how to be in better relationships with everyone in our life. Below is a snapshot inventory you can take to see how well you are honoring the spiritual principle found in this Tradition (in and out of the rooms of A.A.).

Step Two of the Big Book, the foundation of Alcoholics Anonymous (AA), suggests people should believe in more than just themselves. Step Two states, "We came to believe that a power greater than ourselves can restore to sanity." The idea here is the belief in a higher power beyond what we can see. This isn't implying that if you don't believe in God then you are insane. Rather it suggests humbling yourself towards this new outlook in your recovery. The backbone to Step Two — the idea that a higher power can restore sanity — suggests that we open our minds, either religion-based or spiritualbased, and embrace a higher power. Think of this step as a tool to contemplate how its mere existence can alter your outlook, relationships, and life. Think about what a higher power means to you. Indeed, attending meetings can provide you a sense of spirituality and support, but so can activities like surfing, spending time in nature, reading, and being creative. So how do you define spirituality as personal? Step Two encourages you to build on what you learned in Step One. For example, in step one, you accept you are powerless. Step two bridges off of step one by accepting you can't recover inde-

pendently; you need some form of help. Your version of a higher power can aid you in your recovery. A higher power is defined as a



over people's lives and nature. This you to think about what makes you definition, however, is subjective. Bill W., the co-founder of AA, found he could accept the concept of a higher power if it did not connect spiritual belief and religion. AA specifies that it isn't affiliated with any sect, politics, denomination, organization, or institution. Your own definition of spirituality means you receive something in return from your devotion to your practice — for example, yoga aids in connecting the mind and body. When you practice yoga, you learn to interpret messages from your body and quiet your mind. Quieting your mind gives you the time to process feelings of stress, anxiety, anger, and depression.

FINDING SPIRITUALITY - We are all individually responsible for finding and connecting with our spirituality. Let's say you engage in detoxification, inpatient, or outpatient program. During a therapy

spirit (or god) that has divine power session, your therapist may ask tick, or how you connect with yourself. The best answer would be what brings the most joy, peace, and purpose to your life.

> **RESTORING SANITY -** A 12-step program will help repair the damage caused by alcoholism to both you and those around you. Remember, Step Two doesn't mean you're insane. The behaviors you display, mixed with an impaired and negative mindset, are a result of addiction and not indicative of your mental state. Belief and acceptance in a higher power in recovery will help you "restore sanity."

BROKEN RELATIONSHIPS - Damaged relationships come with the territory of addiction. Your words and actions can cause pain, anger, or resentment in both yourself and others. With a 12-step program, your loved ones can begin to express their emotions in a healthy environment. (continued on page 4)

(con't) Step Two of AA enables you to assess your behaviors and see the damage caused by your alcoholism. While processing your actions, look within. Consider how you mistreated yourself through self-destruction. Recognizing, accepting, and changing your thoughts will restore — or instill for the first time — a sense of selfworth.

SANITY - Finding a higher power that resonates with you will help you discover a better version of yourself. "Sanity" occurs when you accept sobriety as a process, not a means to an end; sobriety ebbs and flows. For example, there are

days when you are balanced and others when you need to find balance. Each day is an opportunity for improvement by accepting where you are, where you want to go, and how embracing Step Two can get you there.

February 1: 1918: Original date set for Bill Wilson's mar-

riage to Lois Burnham. The date was moved up because of the war. 1942: Ruth Hock, AA's 1st paid secretary, resigns to get married.

February 2: 1942: Bill Wilson paid tribute to Ruth Hock, AA's first paid secretary, who resigned to get married. She had written approximately 15,000 letters to people asking for help

February 5: 1941: Pittsburgh Telegram ran a story on the first AA group's Friday night meeting of a dozen "former hopeless drunks."

February 9: 2002: Sue Smith Windows, Dr. Bob's daughter died.

February 10: 1922: Harold E. Hughes was born on a farm near Ida Grove, Iowa. After his recovery from alcoholism, he became Governor of Iowa, a United States Senator, and the leading dark horse for the Presidential Democratic nomination in 1972, until he announced he would not run. He authored the legislation which created the National Institute on Alcohol Abuse and Alcoholism, and other legislation to help alcoholics and addicts.

February 11: 1938: Clarence Snyder ("Home Brewmeister" in 1st, 2nd & 3rd editions) had his last drink.

February 12: 1945: World War II paper

February 13: 1937: Oxford Groups "Alcoholic Squadron" met at the home of Hank Parkhurst ("The Unbeliever" in the 1st edition of the Big Book) in New Jer-

1940: With about two years of sobriety, Jim Burwell ("The Vicious Cycle") moved to the Philadelphia area and started the first Philadelphia A.A. group.

February 14: 1971: AA groups worldwide held a memorial service for Bill Wilson.

February 15: 1946: AA Tribune, Des Moines, IA, reported 36 new members since Marty Mann had been there.

February 16: 1941: Baltimore Sunday Sun reported city's first AA group begun in 1940 had grown from 3 to 40 members, with five being women.

February 18: 1943: AA's were granted the right to use cars for 12th step work in emergency cases, despite gas rationing.

February 20: 1941: The Toledo Blade published first of three articles on AA by Seymour Rothman.

February 21: 1939: 400 copies of the Big Book manuscript were sent to doctors, judges, psychiatrists, and others for comment.

February 22: 1842: Abe Lincoln addressed the Washington Temperance Society in Springfield, IL.

February 23: 1959: AA granted "Recording for the Blind" permission to tape the Big Book.

February 24: 2002: Hal Marley, "Dr. Atti-

tude of Gratitude," died. He had 37 years of sobriety. Hal testified, anonymously, before the U.S. Senate Subcommittee on Alcoholism and Drug Abuse on December 3. 1970.

February 26: 1999: Felicia Gizycka, author of "Stars Don't Fall," died. In 1958 she married John Kennedy Magruder and divorced him in 1964. For most of her professional career, she went by the name Felicia Gizycka.

February 28: 1940: First organization meeting of Philadelphia AA was held at McCready Huston's room at 2209 Delancy Street.

Other February happenings for which we have no specific dates: 1916: Bill Wilson & sophomore class at Norwich University was suspended for hazing. 1938: Rockefeller gave \$5,000 to AA. 1939: Dr. Harry Tiebout endorsed AA, the first psychiatrist to do so.

1939: Dr Howard of Montclair, NJ suggests swapping "you musts" for "we ought" in the Big Book.

1940: 1st AA clubhouse opened at 334-1/2 West 24th Street, NYC.

1946: Baton Rouge, La., AA's hold their first anniversary meeting.

1946: 1946: Des Moines Committee for Education on Alcoholism aired its first show on KRNT.

- Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Longtimers?
- Am I absolutely trustworthy, even in secret, with AA Twelfth Step jobs or other AA responsibility?
- 3. Do I look for credit in my AA jobs? Praise for my AA ideas?
- 4. Do I have to save face in group discussion, or can I yield in good spirit to the group conscience and work cheerfully along with it?
- 5. Although I have been sober a few years, am I still willing to serve my turn at AA chores?

- 6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?
- 7. Why is it necessary that a healthy relationship be one in which the members are equals?
- 8. How do you feel and react when someone tries to or dominates in your relationships?
- 9. Do you have an inherent tendency to dominate people around you? How can you correct his defect of character?
- 10. Are you someone who is always willing to allow someone else to take control and then complains because you don't like what was done, yet were unable to make a decision yourself?

- 11. What is the difference between suggestions, advice, and guidance?
- 12. Is God or a Higher Power the only authority in your relationships? How does this Higher Power express Himself to you when making any decisions?
- 13. Why is it necessary to give the minority opinion an open-minded evaluation in a group conscience?
- 14. Why is humility a necessary ingredient in applying Tradition II to your relationships?

Step Two: My Experience

In Step Two, we come to believe our sanity can be restored by a Power greater than ourselves. When I heard this, I was a little confused. What does this mean? Are you implying that right now I am insane? My answer quickly came from my sponsor. He said, "Yes, you are insane; you continue to drink and use drugs even though you know there are going to be extremely negative consequences." That is the definition of insanity, doing something over and over expecting different results.

Okay, I can accept that most of the situations I have been in when I'm drinking have been a little crazy. From jumping off of bridges to driving like I was in the Daytona500 kind of crazy! These were things I just thought you did for fun, but now looking back I realized that was insane thinking. Understanding there was something out there that has a better grip on reality then I did was not hard. I mean I should be dead, but something, and I don't know why, was looking out for me. My sponsor asked me to read page 62 – 63 in the AA Big Book. It says:

"Selfishness – self-centeredness! That, we think, is the root of our troubles. Driven by a hundred forms of fear, self-delusion, self-seeking, and self-pity, we step on the toes of our fellows and they retaliate. Sometimes they hurt us, seemingly without provocation, but we invariably find that at some time in the past we have made decisions based on self which later placed us in a position to be hurt.

So our troubles, we think, are basically of our own making. They arise out of ourselves, and the alcoholic is an extreme example of self-will run riot, though he usually doesn't think so. Above everything, we alcoholics must be rid of this selfishness. We must, or it kills us! God makes that possible. And there often

seems no way of entirely getting rid of self without His aid. Many of us had moral and philosophical convictions galore, but we could not live up to them even though we would have liked to. Neither could we reduce our self-centeredness much by wishing or trying on our own power. We had to have God's help.

This is the how and why of it. First of all, we had to quit playing God. It didn't work. Next, we decided that hereafter in this drama of life, God was going to be our Director. He is the Principal; we are His agents. He is the Father, and we are His children. Most good ideas are simple, and this concept was the keystone of the new and triumphant arch through which we passed to freedom.

When we sincerely took such a position, all sorts of remarkable things followed. We had a new Employer. Being all powerful, He provided what we needed, if we kept close to Him and performed His work well. Established on such a footing we became less and less interested in ourselves, our little plans and designs. More and more we became interested in seeing what we could contribute to life. As we felt new power flow in, as we enjoyed peace of mind, as we discovered we could face life successfully, as we became conscious of His presence, we began to lose our fear of today, tomorrow or the hereafter. We were reborn."

This was a large chunk of information for me to even start to comprehend, especially in early sobriety. So, let me break it down as simply as I can. Ask yourself this, "do I believe that some Higher Power can help me get sober?" If you say yes, then that is all you need to move on in the steps. Remember step two does not say "immediately believed," but rather *came to believe*. I have come to believe that my Higher Power is the only reason that I am still sober to this day.





Let them know that if they want to come back and need additional accommodation, we can help arrange that and/or provide a group contact to help with arrangements.
- 4. For any verbal communication barriers. It is often best to provide information in writing or text. Many smartphone apps are available for immediate accessibility such as talk to text (AVA) and text to talk, image reading/ screen reading (Envision AI) and even sign language translators and text to sign language.

events, including an upload field to add flyers for the event. Also includes a link to Adobe's free PDF converter, because PDF format is preferred. Added additional options to the Contact form. Updated the Group Listing Guide.




