A New Year's Resolution or A New Year's Inventory?



We alcoholics tend to look down on New Year's Eve as "amateur night." We often stay off the highways, believing them to be filled with dangerous, untrained, drinkers who have no tolerance for alcohol. We like to believe that when we drank and drove, we did it well. There is a little bit of truth in this, because we did develop a tolerance for alcohol, but mostly it is what the Big Book calls "gutter bravado." Our tolerance just allowed us to drink more, and we were just as foolish as anyone else.

Because we looked down on New Year's eve, we usually didn't make New Year's resolutions, either. That didn't matter, because most New Year's resolutions are quickly forgotten, or quickly broken. They don't amount to anything, because they aren't backed up by anything. I suggest that, now we are sober, we make a New Year's Inventory rather than New Year's Resolutions.

The Big Book uses the image of a commercial inventory. It says "One object is to disclose damaged or unsalable goods, to

get rid of them promptly and without regret." In steps four, five, and ten, we do just that. Any day is a good day to look at our lives and see what needs to be disposed of, promptly and without regret.

When I was sixteen years old, I worked in a supermarket. I remember, during inventory, standing on a ladder and counting cans of Campbell's soup. I dropped most of them in a shopping basket as I counted. A few cans were old and dented, or old and leaking. I dropped them into a cardboard box, because they were unsalable. After being counted, they would be disposed of promptly, and without regret.

"Right now" is always a good time to take an inventory, to see what in our lives is of great value, to be enhanced in the days to come, and what can cheerfully be left behind. New Year's is just a convenient reminder. The Big Book language, "to get rid of them promptly and without regret," spares us from excessive guilt. Some things just wear out or are no longer useful.

Before Christmas, my wife Priscilla who is 77 years old, noticed that she was getting light headed a couple of times a day. She checked in with her doctor who asked her to wear a 24/7 heart monitor for a month to detect suspicious patterns. Within a half a day, it detected that her heart was stopping and it struggled to restart. The next morning, she was called into Regions Hospital in Saint Paul for an exam and told she needed a heart pacemaker. It was put in at 8 a.m. the next morning, and she was home again by 3 in the afternoon. Neither of us were upset. I just thought, "The natural pacemaker is worn out. It has to be replaced promptly and without regret."

The Twelve Step program's tools of taking inventory and taking action worked well for both of us as she is in Al-Anon. Within one more day, Christmas Day, she was feeling fine, just sore from the incision spot. Whether it is physical health, mental health, emotional health, or spiritual health, (continued on page 2)

(con't) it is useful for us to take our own inventory as we go along, with help from sponsors, doctors, counselors, and God. When I find something wrong with me, I think of those leaky soup cans, and do everything I can to get rid of it promptly and without regret. Happy New Year to everyone!

The 12 Step program is a recipe for recovery. If we follow the directions thoroughly, as outlined in the Big Book of Alcoholics Anonymous, our Basic recovery text, we can recover like the hundreds of thousands alcoholics before us.

It is like baking a chocolate cake. If you follow the recipe exactly, you will make a chocolate cake. There is no doubt about it. You don't even have to believe you are going to make a cake, you will make a cake regardless of what you believe.

But what happens when we leave something out of the recipe such as baking powder? The cake will not rise. What happens if we leave the sugar out? It will not taste very good. What happens if we forget


to bake it? Leave enough of the ingredients and steps out of the recipe and in the end it will not even look like a cake, just a batch of goop.


Dr. Bob was once asked, "what is the most important step?" He replied, "think of the 12 steps as the 12 spokes of a wheel. Take one spoke out and the wheel will continue to turn, but it has been weakened. Removal of another spoke and you further weaken the wheel. Remove enough spokes and the wheel will eventually collapse. So it is with our 12 Step program. Removal of any of the steps will eventually result in a collapse."

Of alcoholics who came to A.A. and really tried, 50% got sober at once and remained that way; 25% sobered up after some relapses, and among the remainder, those who stayed on with A.A. showed improvement. Other thousands came to a few A.A. meetings and at first decided they didn't want the program. But great numbers of these-about two out of three-began to return as time passed. (pg. xx, A.A. 4th Ed.)

If we thoroughly follow the 12 Step recipe, we can recover. We don't even have to believe, just be willing to believe and we can recover from a seemingly hopeless state of mind and body.

Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.

The purpose of this blog is to enhance UNITY through thought and discussion of our basic understanding of what is meant by UNITY and to encourage learning and practical application of the Traditions as our path to UNITY. This proposed by asking three questions arising from Tradition One and providing historical published considerations of those questions.

- •What is meant by UNITY?
- •How does the experience of UNITY have singleness of purpose at its heart?
- •How is practicing the Twelve Traditions our pathway to UNITY?
- •Why is the experience of those who came before so necessary to learning and practicing the Twelve Traditions, our path to UNITY?

A.A. Traditions Booklet, Forward by Bill Wilson, 1955: "...if as a movement, we remain a spiritual entity concerned only with carrying our message to fellow sufferers without charge or obligation; then only can we most effectively complete our mission...Unity is so vital to us AA's that we cannot risk those attitudes and practices which have sometimes demoralized other forms of human society."

Grapevine Article, February 1958, A.A. Co-Founder, Bill Wilson: "Our first duty, as a society, is to ensure our own survival. Therefore we have to avoid distractions and multipurpose activity...Sobriety–freedom from alcohol–through the teaching and practice of the Twelve Steps, is the sole purpose of an AA group. Groups have repeatedly tried other activities and they have always failed...we have to confine our AA groups to a single purpose. If we don't stick to these principles, we shall almost surely collapse. And if we collapse, we cannot help anyone."

AA Grapevine, November 1948, Bill Wilson: "The Twelve Points of Tradition are little less than a specific application of the spirit of the Twelve Steps of recovery to our group life and to our relations with society in general. The recovery steps would make each individual whole and one with God; the Twelve Points of Tradition would make us one with each other and whole with the world about us. Unity is our aim."

AA grapevine Article, January 1998, "Unity Seldom Means That We All Agree": "What I have learned is that unity seldom means that we all agree on everything. Nor is unity served by setting aside our concerns and conforming to the majority opinion...My experience has been that unity is best achieved by a full hearing of all points of view, followed by some time for those involved to step back from emotional responses to the issue, as well as careful consideration and prayer...When we need to make a decision it's important for me to allow the group conscience to work and to trust in the process of applying the Twelve Traditions in making our decisions. when I'm able to do this, I feel that I'm part of this Fellowship and that we united in our common disease, our common solution, and our common purpose."

(con't) AA grapevine Article, April 2000, "Divine Wisdom": "Mention our Twelve Traditions, and I immediately think of the mistakes that early AA members made. That's where our Traditions came from, and each chapter in our "Twelve and Twelve" is a brief, often humorous account of problems encountered by early groups because of the character defects of sober alcoholics and the mistakes they made out of good, if misguided, intentions. The Traditions gave us both a sweeping inventory of the problems that threatened early groups, and an analysis of how the problems were rooted in and sprang from the alcoholic personality."

The Spiritual Principle for Step One is HONESTY

While I was active in my alcoholic disease, honesty was not a spiritual principle I gave much thought to other than "I bought the last round, so this one is your turn" or "I did NOT say that about so and so (when I probably had)". My actions and behaviors were not honest. While I was hitting bottom and bouncing along I began to get a few moments of clarity – having a true glimpse of who I had become under the influence of alcohol. Life was not working the way I wanted it to, people were not behaving the way I wanted them to and none of it was my problem.

When my first sponsor brought me to my first meeting of Alcoholics Anonymous I felt safe, I felt comfortable sitting in a chair and not having to say anything, I heard the language of the heart but couldn't tell you the words of it. Step One is the only step we can work perfectly. The other eleven steps of the program of Alcoholics Anonymous are ideals to which we should strive toward.

The decision for Step One is Do I want God's mercy or to continue with the merciless obsession? After reading the Doctor's opinion in the Big Book of Alcoholics Anonymous, reading Step One in the Twelve by Twelve with my sponsor then looking at the unmanageability of my life and the consequences of my actions the decision became easier to make. I did not want the merciless obsession any longer. It took my several more weeks to read the complete first 164 pages of the Big Book of Alcoholics Anonymous then to have the head to heart drop to actually believe I was a real alcoholic.

Now, having many days and years of sobriety to reflect upon, Step One continues to serve me on a regular basis with the daily business of living even though alcohol has been out of the picture for some time. I can take ANY situation that I have allowed me to be in a state of restless, irritability and discontent and apply Step One followed by the rest of the steps and come to a place of freedom once again.

STEP ONE

Step one combines simplicity with unadorned honesty. To begin the recovery journey all I had to do was make a decision; admit something. It was now an undeniable fact that I had reached a point where the ability to resist the compulsion to take a drink had been destroyed. Quantity and frequency choices were no longer mine.

Here's how most of my days would start. We owned and I operated a restaurant and bar in rural Indiana. I mean rural – corn, soybeans, hogs, and dairy cows rural. As experienced drinkers know, the standard shot glass is 2 oz. with a white line at the 1 oz. level. At six o'clock in the morning I filled the glass up to the line with whiskey, added a blurb of peppermint schnapps, dribbled in several drops of bitters, tossed it down the hatch and chased it with black coffee. Three of these little beauties in the space of five minutes eliminated those pesky hangovers.

Needless to say, my life needed new management. I suffered from what I call alcoholic usurpation, a form of thievery that robbed me of the ability to apply reasoned judgment to the reality of my daily life. Alcohol played the role of a skilled embezzler and I, the alcoholic, played the role of co-conspirator using denial, blaming, feigned ignorance, and other concealment tactics to cover the losses. Inevitably, bankruptcy occurred. The cover up was exposed. Confession time had arrived.

In one sense, my admission of powerlessness over alcohol was motivated by a feeling of guilt associated with and derived from the consequences of my drinking.



But more importantly, the admission signified my unconditional surrender. Life looked bleak.

My first experience with AA was part of a treatment program in 1980. By 1984, reliance on willpower had led to perpetual relapses; helplessness and hopelessness saturated my entire being. These two feelings combined with self-loathing drove me back into the rooms of AA where I was met with empathy and camaraderie, and surprisingly, the realization that I had already done Step 1.

Four years of intermittent AA attendance had not resulted in sustained sobriety but it had not been a complete waste. I

had seen the joy and heard the laughter; I had enjoyed the self-deprecating humor, and had learned from the stories of success and the agony of failure. I wanted what those people had, I wanted sobriety.

At first glance, Step One may appear to be somewhere between formidable and impossible to a still suffering alcoholic who had been beaten down to a near zero sense of self-worth. Here is where reason and common sense finally came into play for me. Every AA meeting I attended presented evidence of successful recovery. All I needed to do was open my mind to the possibility that I too could succeed. As distasteful as the concept of powerlessness may be, Step One restricts it to one thing, powerlessness over alcohol. Completion of this part of the step requires only one concession - a commitment to abstinence.

As the third tradition of AA states "... the only requirement for AA membership is a desire to stop drinking." Pure simplicity! Well, maybe not so simple. One might ask, does doing step one actually require a commitment to abstinence? Based on the wording of the third tradition, I think it does. If I state a desire to achieve something, the statement itself carries with it the implicit necessity for commitment. My stated desire to stop drinking carries with it a commitment

else could the word stop mean? The second suggestion in Step 1 is also a limited request. It does not say that we alcoholics have always lacked the competence to manage our lives. The implication is clear, my powerlessness over the mind altering effects of alcohol created the unmanageability. More simplicity – remove the cause, then rebuild a lifestyle based on reason and common sense. I was told repeatedly that compared to a life based on alcoholic

fiction, reality isn't that bad. Beyond any doubt, I now know that to be true. In retrospect, I now understand that the intense pain created by my addiction motivated two significant changes in attitude. Four years of ambivalence toward the seriousness of my addiction had been replaced with the belief that sobriety was both necessary and doable. Today, those two principles, necessity and doability, are tools I apply to important decisions on a regular basis. The completion of Step One pri-

marily required honesty, but it also suggested the immediate need for some humility and gratitude. Four years of failure to stay sober had taught me that reliance on my own volition was not a winning strategy. Powerlessness and unmanageability needed to be reversed. I had finally realized the necessity for outside help, and I already owed a debt of gratitude for the "welcome back" support I had received. Help was staring directly at me; all I needed was enough humility to accept it.

January 17: 1919: 18th amendment, "Prohibition," became law.

January 19: 1940: First A.A. group met in Detroit, Mich. 1943: Canadian newspaper reported eight men met at "Little Denmark," a Toronto restaurant, to discuss starting Canada's first A.A. group. 1943: Wilson's returned from 1st major A.A. tour started in Oct 24 1943. 1999: Frank M., A.A. Archivist since 1983, died.

January 20: 1954: Hank Parkhurst, author of "The Unbeliever" in the first edition of the Big Book, died in Pennington, NJ.

January 21: 1951: A.A. Grapevine published memorial issue on Dr. Bob. 1954: Hank P who helped Bill start NY office dies in Pennington, New Jersey.

January 23: 1961: Bill W. sent an appreciation letter, which he considered long-overdue, to Dr. Carl Jung for his contribution to A.A.

January 24: 1918: Bill Wilson and Lois Burnham were married, days before he was sent to Europe in WW I. 1945: 1st black group St. Louis 1971: Bill Wilson died in Miami, Florida

January 25: 1915: Dr. Bob Smith married Anne Ripley.

January 26: 1971: New York Times published Bill Wilson's obituary on page 1.

January 27: 1971: The Washington Post published an obituary of Bill Wilson written by Donald Graham, son of the owner of the Washington Post.

January 30: 1961: Dr. Carl Jung answers Bill's letter with "Spiritus Contra Spiritum."

Other significant things that happened in January:

1938: Jim Burwell, author of "The Vicious Cycle," a former atheist, gave A.A. "God as we understand Him."

1939: 400 copies of manuscript of Big Book circulated for comment, evaluation and sale.

1944: Dr. Harry Tiebout's first paper on the subject of "Alcoholics Anonymous".

1944: Onset of Bill's 11 years of depression.

1948: 1st A.A. meeting in Japan

1951: The A.A. Grapevine published memorial issue on Dr. Bob.

1984: "Pass It On," the story of Bill W. and how the A.A. message reached the world, was published.

A.A. Number Three: Bill Dotson--Recovery by God's Power

In the last two years--after 20 years of research and digging--we have been able to put together the simple facts about how the first three AAs got sober by the power of God. The details are laid out in The Dick B. Christian Recovery Guide, 3rd Ed.

The first three were, in this order, Bill Wilson, Dr. Bob Smith, and attorney Bill Dotson. Though a few Christian A.A. critics, and others opposed to A.A. have contended that none of the early AAs was a Christian, the facts show otherwise; and we have documented them. The important facts about these early Christian AAs have to do with the time, the way, and the process by which they got sober. All were required to declare a belief in God. All were required to declare that Jesus Christ was their Lord and Savior. And all were required to study the Bible, pray, and observe a Quiet Time. And-there were no Twelve Steps, no Twelve Traditions, no pages of a Big Book to follow, no drunkalogs to hear, and no meetings as we know them today. See our class: "Introductory Foundations for Christian Recovery".

How, then, did the A.A. pioneers get sober, maintain sobriety, and make new lives? The answer is that they built on the principles that the first three AAs had proved would work. Each of the first three AAs believed in God and said so. Each of the first three AAs had accepted Jesus Christ as their Lord and Savior. And each of the first three AAs had been involved in extensive Bible study--something not fully established until our recent books on The Conversion of Bill W. and Dr. Bob of Alcoholics Anonymous. Each of the first three AAs had turned to God for help, been cured of their malady, and so stated. See particularly pages 180-181 and 191 of the current edition of "Alcoholics Anonymous."

Now, we have a very good picture of the story concerning Akron attorney Bill Dotson-the third AA to get sober and maintain sobriety, and the first alcoholic upon whom Bill Wilson and Dr. Bob Smith "worked" successfully. Here is the Dotson story as we have discovered it in this month of January, 2011--particular as verified by a tape of Bill Dotson's recorded When



talk now being circulated. Dotson had a seemingly hopeless battle with alcohol. By the time he met Bill and Dr. Bob, Dotson had been hospitalized for alcoholism eight times in the previous six months.

He had been a Deacon and Sunday School teacher. He and his wife were much involved in church life. He believed in God. He often referred to the Bible. And he stood on the teachings of Jesus. In fact, in his recorded talk, Dotson opened the address by praying "in the name of Jesus." Typically, Dotson had prayed a good deal, declared many times he would quit drinking, and--as he put it--drank too much, got drunk too often, and been unable to guit. Dotson also recognized the role of the Devil in his plight. One frequent temptation from the Adversary, came, said Dotson, in the argument that if Dotson quit, he would have "no fun." As Dotson put it, the Devil was paying him lots of attention.

Finally, on his last hospitalization, Dotson's wife told him he was going to quitsomething he doubted. She said that two men (Bill and Dr. Bob) had been "licked" just as he was, and that they had the same weakness that he did. She assured Dotson that these two would not accept a cent for their services

When Bill Wilson and Dr. Bob visited Dotson, they made some very simple points:

- (1) They asked Dotson if he wanted to quit.
- (2) They asked him if he could do it by himself.

- (3) They asked him to admit he had his drinking problem.
- (4) They asked him if wanted help and would ask for help.
- (5) They said the action had to come from Dotson and that if he wasn't interested, they would be on their way.
- (6) Then they asked him if he believed in a "higher power." But Dotson replied emphatically stated that he believed in God and the Bible.
- (7) They told him that if he sought and received help, it would be necessary for him to help others as well. He was told he must "take the message" to others.
- (8) They told him he needed to call on God for help, and they left.
- (9) In their absence, Dotson reflected and asked God for help. He was instantly cured.
- (10) On the return of Bill, Dr. Bob, and Mrs. Dotson, Dotson declared he was leaving and never drank again. The date was July 4, 1935.

Wilson declared that this date marked the founding of the first A.A. fellowship--Akron Number One. Both Wilson and Dotson confirmed Bill Wilson's statement that the Lord had cured him of his terrible disease and that he just wanted to keep talking about it and telling people (See the 4th edition of the Big Book, page 191).





Ensure that your meetings' accessibility status is correctly listed in your local Intergroup directories. The intergroup directories are where The Meeting Guide app pulls its information from. Use this QR code to locate your local intergroups contact information. Correct listings ensure that those with disabilities can accurately choose what meetings will

work for their needs. Note that any wheelchair accessible meeting will also be walker accessible.

What to do if someone with Accessibility needs attends your meeting?

- 1. Consider assigning a "buddy" as a point person for any needed assistance during the meeting such as getting them coffee or help finding the bathroom. Ask the person what would be helpful in terms of
- 2. Preferential seating up front may be helpful for the hard of hearing, and the aisle or other seating for
- 3. Afterward provide phone numbers of local members, the Accessibilities Committee contact information Accessibilities@marylandAA.org and that of the local intergroup. Let them know that if they want to come back and need additional accommodation, we can help arrange that and/or provide a group contact to help with arrangements.
- 4. For any verbal communication barriers. It is often best to provide information in writing or text. Many smartphone apps are available for immediate accessibility such as talk to text (AVA) and text to talk, image reading/ screen reading (Envision AI) and even sign language translators and text to sign language.

Hello All,

Following the vote at the Area 29 Assembly on Saturday, Dec. 14th, regarding movement of District 46 to Area 12 Delaware, a member in our Area asked the MGS Board of Directors to review the action approved, suggesting it is "unactionable". The MGS bylaws do specify as a Board responsibility to advise and guide the Area Assembly through their past experience, service and wisdom. Therefore, the MGS Board of Directors agreed to a review, to determine whether the motion is indeed unactionable.

After prayerful consideration the Board did not find the motion to be fully unactionable. There is a path forward to fulfill what would be best for the groups in District 46, as determined by them, while keeping in mind past precedent regarding such moves and our Fourth Tradition regarding taking actions that would affect other groups or AA as a whole. As a board we did agree that additional actions are necessary, and perhaps clarity regarding the motion would be helpful. Thus, we agreed that the motion is "unactionable at this time". To fulfill our role in advising and guiding we recommend this matter be brought to the next Area Committee meeting for further discussion, keeping in mind the following points:

- An Area serves its members, and if it would be best for our members for this change to happen, we should endeavor to facilitate that as smoothly as possible;
- There is much precedent for moving individual groups from one Area to another;
- Movement of Districts from one Area to another has been exceedingly rare. Thus, we should keep in mind the potential effect on groups in the district that have not expressed a desire to move, neighboring districts, and AA as a whole. We are aware of one such move in our history (1985 moving the Virgin Islands from Area 77 Puerto Rico to Area 15 South Florida). That was brought before the General Service Conference as it involved changing geographical boundaries. We should be wary of establishing a new precedent, as that could affect AA as a whole;
- The Area 12 Assembly would need to also approve the change. Perhaps the motion should reflect Area 29's support if also approved by the Area 12 Assembly;
- Perhaps the change in Area boundaries will indeed increase service participation amongst the groups in District 46

The MGS Board has no opinion regarding the specifics of this change in Area boundaries, believing that a fully informed group conscience generally reflects God's will. And we will support whatever is eventually decided to be best for our fellowship and our members. However, after discussion we are united in our opinion that Area 29 should further discuss the points above, particularly those surrounding past and future precedents and the need to obtain the approval of the Area 12, Delaware Assembly.

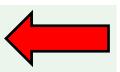

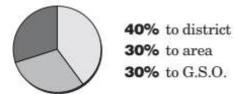
