**The Third Step Prayer** remains on my refrigerator year after year—not that I haven't long ago memorized it, but it evokes a different meaning with each reading starting with the first sentence:

## "God, I offer myself to Thee—to build with me and do with me as Thou wilt."

• Here I realize that I don't know exactly God's will for me, but I do have a fairly good idea. I am left off the hook here by a sentence on page 85 of the Big Book: "Every day is a day when we must carry the vision of God's will into all our activities." And yes, do have a general idea (vision) of appropriate action as each new circumstance arises. Of course, this may involve many Eleventh Step prayers throughout each day.

## "Relieve me of the Bondage of self, that I may better do Thy will."

 Before learning about the Twelve Steps I had no Idea of what constituted the bondage of self. But then when I did Steps Four and Five with my sponsor he was not fain to point them out. I have come to believe there is an underlying four-part set of grosser handicaps which populate this deadly barrier from truth in drink: Selfishness, dishonesty, resentment and fear.

## "Take away my difficulties that victory over them may bear witness to those I would help of thy power, Thy love, and Thy way of life."

• I developed a good notion of my "difficulties" when I bring to light the many times I have taken the easy path when I knew, absolutely and for sure, that it was not my vision of God's will. As the famous comedian, Red Skelton, used to say: 'I just dood it!"

## "May I do Thy will always."

 I used to think that living the AA program of action was calling my sponsor, going to meetings, conventions, Twelve Stepping, etc. However, I have come to believe that "always" means how I drive a car or a nail, my attitude toward my fellow man, or, as a matter of fact, everything I do, or fail to do—ALWAYS!

## The Third Step

## **Promises read:**

"All sorts of remarkable things followed. We had a new Employer. Being all powerful, He provided what we needed, if we kept close to Him and performed His work well. Established on such a footing we became less and less interested in ourselves, our little plans and designs. More and more we became interested in seeing what we could contribute to life. As we felt new power flow in, as we enjoyed peace of mind, as we discovered we could face life successfully, as we became conscious of His presence, we began to lose our fear of today, tomorrow or the hereafter. We were reborn." Alcoholics Anonymous p.63

When I was new, still toxic, dazed and confused, I related to the idea in Step Three that I had a new Employer who, in exchange for my efforts on His behalf, would take care of me and provide everything I needed for a happy life--just like a human boss who appreciated my contributions to his company.

Bill included a job description. If I wanted the beautiful prom-

ises of Step Three I had two jobs: "if we kept close to him and performed his work well." That's it. Even as I read it today it doesn't sound too difficult of an assignment. All I have to do to get all the gifts of Step Three is to develop "conscious contact" with the God of my understanding and to practice "love and service" as a way of life.

I realize that fulfilling the conditions of the Step Three promises is not about reading spiritual books, meditating on a mountain top, or denying myself anything. I simply need to become aware of those things that separate me from God and from my fellow men and women and make things right as best I can. Chuck C. called it "uncover, discover and discard." Just going to meetings and dumping my problems does not accomplish this. I must decide to take all the actions called for in the remaining nine steps. I must desire with all my heart to be changed at depth and I must be willing to take the actions that prove I mean it.

I certainly haven't fulfilled the conditions of "love and service" perfectly, but nevertheless I see these promises slowly becoming my reality.

## Dr. Harry N., **Patron Saint of Cleveland AA**

Harry N. was born 1897 in Cleveland. He graduated valedictorian of his class at St. Carroll University, and went on to Western Reserve Medical School, now part of CWRU, earning his MD degree in 1922. He interned at St. Vincent Charity Hospital becoming a surgeon on their staff. He married in 1926 and a bit over a year later his wife gave birth to a son, Harry Jr.

Dr. Harry was generous in both time and money. Though trained as a surgeon, he also practiced Family Medicine involving house calls. He instructed his staff, "If they can only pay a nickel, then that's what we charge them. They pay their bill and keep their self-respect, and they will not be afraid to come back for treatment when they need it."

In the 1930's Harry's drinking progressed to the point where he took a leave to become a cowboy on a working ranch in

Texas for 6 months in 1936. While his strength and health improved, it did not entirely stop his drinking. Upon return he and his wife searched for alternatives, seizing on an opportunity for him in 1937 to join the half dozen Clevelanders traveling weekly to the Oxford Group Meeting in Captain in the Medical Corps, leaving Akron. He then signed on with the few Ignatius College, which later became John men meeting at the home of Albert "Abby" G in Cleveland Heights as an Alcoholics Anonymous Group starting in May 1939.

> In the 1930s and '40s alcoholism was looked upon as a moral failing instead of a disease. Few hospitals admitted alcoholics. And, even then, admitted them under the guise of alcoholism side effects. Dr. Bob and Dr. Harry approached Dr. Kitterer, an ordained minister who was the administrator of Cleveland's Deaconess Hospital to get beds to hospitalize alcoholics there. Dr. Kitterer went to bat with his board and in May 1939 they entered their first patient. Dr. Harry managed to persuade many other hospitals to make rooms available for alcoholics.

> In 1941 Dr. Harry began hospitalizing patients at St. Vincent Charity Hospital under the care of Sr. Lucille. A hospital publica-

tion titled "A History of A.A. Activities" referred to Dr. Harry as "patron saint of Cleveland AA," high praise indeed. But Harry's AA service there was about to end. World War II was exploding and in 1942 Dr. Harry was called to service as a Cleveland to report on September 30th at Bowman Field in Louisville KY. AA at St. Vincent floundered for a while until Dr. Victor Ippolito took over that ward. In 1952 Sr. Ignatia came from Akron and opened Rosary Hall there.

In late 1942, Captain Harry contracted pneumonia on his way to reassignment and died January 3, 1943 at the age of 45. In his few years on earth, and very few years of sobriety, Dr. Harry accomplished a great deal for us. We can only speculate how he might have changed local AA history given a bit more time.

- 2. False Evidence Appearing Real
- Frustration, Ego, Anxiety, Resentment
- 4. Failure Expected And Received
- 5. Feelings Every Alcoholic Rejects
- 6. Feelings Expressed Allow Relief
- 7. Fighting Ego Against Reality
- 8. Forget Everything and Run 9. Face Everything and Recover!
- 10. Forgetting Everything's All Right


For a long time, in many areas, we hear the plaint "AA has changed. It isn't like it used to be." Further inquiry reveals sadness and dismay on the quality of present-day sponsorship, an almost total ignorance of the traditions and utter indifference to their application, the format of AA meetings, the intermingling of AA Groups and Clubs and the numerous selfappointed power-drivers who operate AA groups and non-AA programs in the name of AA and speak publicly for AA.

We believe there is some validity in all these observations, and can attribute part of it to "changing times" – membership growth- and the development of other agencies and treatments for alcoholics, plus a reduction of public stigma and the fact that so many older, personally indoctrinated members have passed from the scene. AA seems no longer – The Last Port of Call!

There is a tendency for new people to regard AA in much the same light as other fraternal groups, with the belief that there must be people in "authority" to "run" things. It is also natural for certain egocentric individuals to respond and endeavor to assume the mantle of authority.

The phenomenal growth of AA finds many new groups and areas without experienced members to suggest, advise and explain the reasons for certain procedures. Too often meetings do turn into "bull-sessions" or repetitious drunk-a-logs that become boring and distasteful.

We believe that co-founder Bill W.'s advice: "SHOEMAKER, STICK TO THY LAST!" ... should be heeded more now than ever before. Six months or six years sobriety in AA doesn't make us all experts, or qualify us to run hospitals, treatment centers, state programs or industrial programs. Other talents and aptitudes are essential. AA assures us of only ONE thing... a life without the need to use alcohol. Perhaps some of the confusion comes from the concept that everything changes and some may feel the need to modernize AA, its format and objective. However, we believe that "principles" are



not subject to clock or calendar ... and AA is nothing more nor less than a set of principles.

Our other co-founder, Dr. Bob said it all when he pointed out that the 12 Steps are simply, LOVE and SERVICE.

The reason, we feel, that there has been such a change in the approach to sponsorship, is the fact that too many of us now don't care enough! It is too easy to shunt a newcomer into a treatment center and rationalize on the follow-up. In bygone days, if the sponsor didn't care to give of himself... of his time and his love... the alcoholic had no recourse except to return to drunkenness and oblivion.

There were no treatment centers, no referral centers, no hospitals or doctors who would bother with a sick alcoholic. And, out of sheer gratitude, most alcoholics in AA wanted to carry the message and cared enough... to do whatever they could to help. AA seems to be suffering from a dangerous case of "human" shortcomings, egocentricity, selfishness, apathy and ignorance.

We feel too that it is serious enough for all of us to consider the very real possibility that this may be the seed that could blossom into the dissolution of our society. For the ONLY thing that can destroy AA is us. Destruction can only come about through

our disunity. This is why voluntary adherence and knowledge of the 12 Traditions is so essential to our existence, for there is no authority that can legislate unity and singleness of purpose. We are subject only to one ultimate authority... a loving God, as He may express Himself in our group conscience. Our leaders are but trusted servants... they do not govern.

When we adhere to the unalterable principles of the 12 Steps voluntarily, truth and humility are essential in application. and positive results are inevitable. Deviation, or abandonment also bring inevitable results, but of a negative nature. The same set of principles is involved in our group adherence (merely a group of individuals) to the 12 Traditions, calling for an even greater degree of humility and self-discipline. In this way the group conscience is truly sensitized.

If we would stay whole... if we are to fully meet our responsibilities and even more importantly, if we are to survive... we have no choice but to try to abide by the suggestions of all the experiences of all those who have gone before us.

When a sick alcoholic needs help... anywhere... anytime... under any circumstances... and wants it... do we care enough to go all the way with him? How much... do you care?

## **The Truth Behind Tradition Three**

Bill W.'s grandfather was a drunk. Grandfather Wilson, an innkeeper, had had alcohol turn against him. "One Sunday morning in despair he climbed to the top of Mount Aeolus and beseeched God to help him. He saw a blinding light and felt a great wind, and rushed down to interrupt the service at the Congregational Church. Demanding that the minister leave the pulpit, Wilson described his experience to the congregation... Emily [Bill's mother] loved this story about her husband's father, and she told it to her son and husband as often as they would listen. In the eight years that he lived after that experience, the elder Wilson never had another drink." (Cheever, My Name is Bill, p. 17) During Bill's final stay as a patient at Town's Hospital, perhaps the familiar tale of his grandfather's miraculous recovery came to mind. Bill's description of his 1934 "spiritual experience" was remarkably similar to that of his grandfather. When Bill later told the story of his recovery, it was in the form of a 19th century Protestant redemption story of the sort he would have heard repeatedly from his mother. He resurrected that style when it came time to write about the Third Tradition

In the essay on Tradition Three, Bill tells the story of "Ed", an obstreperous atheist/ agnostic, who vociferously and repeatedly disagrees with the predominant religious tone of AA. Ed falls off the wagon while on a sales trip and his pleas for help are rebuffed by his fellows at home. (Bill later was to denigrate the exclusionary attitude and quest for respectability of early AA. Only "pure alcoholics" were to be admitted, he reports. "They could have no other complications. So beggars, tramps, asylum inmates, prisoners, queers (sic), plain crackpots, and fallen women were definitely out" (Twelve Steps and Twelve Traditions, p. 140) and so, apparently, were atheists and agnostics.) Bill relates that, after a couple of weeks, Ed did return to Brooklyn chastened and, Bill implies, freshly converted to the ranks of the religious.

Part of this story is true. "Ed" was really a fellow named Jim B., one of the first ten AA

members in New York. Jim did work selling car polish for a company owned by Bill and Hank. He did go out of town on a sales trip and get drunk. He was rebuffed by the other members. He did sober up and return to New York. Jim, by his own admission, was thereafter less contemptuous of the religiosity of the other members. Bill gets a bit creative in returning to the conversion story format by adding a mysterious interaction with a bible in a hotel room and has Jim appear in the home of an unnamed fellow AA asking if the family had had their "morning meditation", implying Jim had abandoned his disbelief. These parts did not happen. The home in which Jim appeared was Hank's. Hank was also an atheist; the chance that he would have been having a religious meditation is small. Jim never mentioned a bible in relating his story, nor did he ever abandon his disbelief. According to Clarence Snyder (an early AA member from Cleveland): "Jimmy remained steadfast throughout his life and 'preached' his particular [non-God] brand of AA wherever he went." Jim died in 1974, sober 35 years and still an atheist. Jim was responsible for the "God as you understand Him" and "Higher Power" wording of the Steps. Burwell's contribution to Alcoholics Anonymous is considered by many to be second only to that of AA's two co-founders,

Bill, in later years, regretted his earlier position. In 1957, writing in AA Comes of Age (footnote, page 232), Bill said, "Nothing, however, could be so unfortunate for AA's future as an attempt to incorporate any of our personal theological views into AA teaching, practice or tradition. Were Dr. Bob still with us, I am positive he would agree that we could never be too emphatic about this matter." In a Grapevine article in 1961 ("The Dilemma of No Faith"), Bill went further: "In AA's first years I all but ruined the whole undertaking...God as I understood Him had to be for everybody. Sometimes my aggression was subtle and sometimes it was crude. But either way it was it was damaging - perhaps fatally so - to numbers of non-believers."

The first few times I read How It Works, I thought it said we had to let go of our "bad ideas," not our "old ideas." Today I know Bill had it right. It's all the old ideas I've been carrying around for God knows how long that created the dis-ease I drank at for 30 years and the upset that pops up in my life today.

These old ideas are the roots of my character defects that grew up like weeds. If I want to rid myself of a character remove I must remove the root or the weed will just sprout back up. Most of the roots of my character defects are buried so deeply in the recesses of my mind that I don't even realize they are there. That's why self help programs didn't work for me, but AA -- a God help program -- does.

I am way too lazy to look at the root causes of my anger, frustration, fear, boredom and the like unless pain forces me to. I believe becoming "entirely ready" means I have to first hit the bottom. I didn't become ready to quit drinking until I became sick and tired of being sick and tired. The same is true with my character defects. I simply won't weed the garden work unless I'm in some kind of pain that keeps repeating itself like bad Mexican food.

I confronted this kind of pain in 2003 when I reached bottom with my anger. After almost nine years of sobriety, I had become sick and tired of giving away my serenity to people and situations that didn't follow my script. I finally realized that my angry reactions were hurting only me, not the bozos I held responsible. I made peace of mind my number one goal.

I began to pay better attention to myself as I went through my day. When I lost my serenity I tried to remember to ask why. At



first I noticed only the big blow-ups, but as the years passed I became more sensitive to little upsets -- the ones caused by the termites of fear that gnawed silently away at my peace of mind. I identified a number of the "moldy oldies" I had been carrying around since I was a kid like: "You should not criticize me in any way. Don't tell me if I happen to do anything that bothers" (It used to be if you honked your horn behind me in traffic, you were criticizing me, goddammit!) and "you should treat me at all times with courtesy and respect according to my standard of courteous and respectful treatment, not yours." It took a while, but eventually I came to see how irrational these beliefs were. It also became clear I was taking this stuff way too personally.

Today I still get angry when you do or say something that pisses me off, but I have fewer and fewer volcanic explosions. I don't try to suppress it because that just leads to depression. When I get angry I continue to ask myself why I am angry. The answers I receive always lead me back to some, old worn-out idea that I'm carrying around from my childhood.
